#### 5. INFORMATION/DISCUSSION ITEMS - GENERAL

### A. Instructional Services – Presentation: Conejo Valley Adult Education Program

Mike Sanders, Principal at Conejo Valley Adult Education, presented information on the school's program, including the program's background and mission statement and the following program components: Basic Education, Adult Secondary Education, Career Technical Education and Integrated Technical Education Training for ESL Students, Community Support, and Fee-Based programs. Information was also provided on the evolution of Adult Education, the purpose of the Ventura County Adult Education Consortia, categorical funding history, a summary of current funding and annual expenditures, and program highlights and challenges. Mr. Sanders responded to a Board member's questions regarding the program's three funding sources, geographic gaps on the consortia, and programming and fee comparisons with similar programs in the consortia.

### B. Discussion on Amended Local Accountability Plan (LCAP) Goals

Mr. Loo provided the adjusted LCAP goals for the Board's consideration and responded to questions from Board members regarding stakeholder and committee feedback on original goals and suggested adjustments. The Board then discussed language adjustments for each goal and goal structure changes. Following the Board's discussion, consensus was reached on the discussed adjustments as summarized by Mr. Loo.

# C. Human Resources – Adoption of New Board Policy 4119.24, 4219.24, 4319.24 – Maintaining Appropriate Adult-Student Interactions

Mrs. Ashmore provided background on this new Board policy, which provides explicit and clear language on appropriate and inappropriate adult-student interactions and informs employees of the boundaries established within this policy upon initial employment. Mrs. Ashmore responded to questions from Board members regarding how this policy interfaces with Board Policy 4119.21 – Professional Standards, clarification on the policy numbering format, whether an administrative regulation will accompany this policy, and clarification on inappropriate terms of endearment and employee use of social networking sites. The Board discussed language clarifications related to adult-student social interactions through email or social networking sites and extending the requirements of this policy to any adult on campus, including contractors, consultants, and volunteers. The Board reached consensus to provide District staff with the direction to incorporate the recommended language adjustments, which Dr. McLaughlin will provide back to the Board for review prior to approval at the next Board meeting.

**D.** Business Services – 2024-2025 District Facility Use Fees and Rules and Regulations
President Goldberg announced that one(1) public speaker request was submitted, and that speaker received three (3) minutes to speak. Dr. Hayek then provided background on the baseline fee schedule and proposed increase for the 2024-2025 school year. Dr. Hayek responded to questions from Board members regarding facility use fee variance based on type of use and proposed language adjustments on the rules and regulations related to the use of derogatory language and hate speech. Dr. Hayek will incorporate the language adjustments on the rules and regulations prior to Board approval at the next Board meeting.

# E. Business Services – 2024-2025 Child Nutrition Services: School Lunch Meal and Ala Carte Pricing

Dr. Hayek clarified that there will be no change in pricing for school lunch meals for the 2024-2025 school year, and that changes will be made to the availability of ala carte menu items at the elementary level due to staffing shortages and at the secondary level due to lack of popularity and/or those products are served as part of the free school lunch. Dr. Hayek responded to questions from Board members regarding student access to bagels during breakfast and nutrition, elementary participation levels during nutrition, and whether volunteers can assist with food nutrition services.
