# BOARD OF EDUCATION REGULAR BOARD MEETING Wednesday, November 15, 2023

#### 1. CLOSED SESSION

#### A. Comments - Public

President Gill announced that there were no public comment requests submitted, and the Board convened into Closed Session at 5:30 p.m. where the following items were discussed:

### 3. ACTION ITEMS – GENERAL

A. Business Services - Approval of Resolution #23/24-15: Authorizing the District to Apply for Grant Funds from the California Schools Healthy Air, Plumbing, and Efficiency Program
Trustee Gorback made the motion to approve, seconded by Trustee Goldberg. Dr. Hayek clarified that this resolution must first be approved by the Board for the district to apply for grant funds for facility updates. There was no discussion on this agenda item. Motion carried: 5-0, with a preferential "yes" vote from Trustee Kahl.

## B. Board of Education - Discussion and Approval of Letter on the City of Thousand Oaks Crossing Guard Program

Trustee Goldberg made the motion to approve, seconded by Trustee Gorback. The Board discussed revisions to the letter and reached consensus for President Gill to finalize the letter with the requested revisions.

Trustee Goldberg revised her motion to approve the letter as amended, seconded by Trustee Gorback. **Motion carried: 5-0, with a preferential "yes" vote from Trustee Kahl.**

Trustee Sylvester made the motion to approve, seconded by Trustee Powell. Dr. Hayek
responded to a Board member's question regarding details on the three alternates added onto
the bid for this project, and whether the schools not mentioned in the alternates would be
receiving security cameras. Motion carried: 5-0, with a preferential "yes" vote from Trustee
Kahl.

# W. Business Services - Approval of Grant Agreement for the CalSHAPE Program with California Energy Commission

Trustee Powell made the motion to approve, seconded by Trustee Goldberg. Dr. Hayek responded to a Board member's questions regarding the grant participation agreement and approval process and vendor pricing and selection. **Motion carried: 5-0, with a preferential "yes" vote from Trustee Kahl.** 

Trustee Gorback made the motion to approve the remainder of the Consent Agenda as amended, seconded by Trustee Powell. There was no Board discussion on this agenda item. **Motion carried: 5-0, with a preferential "yes" vote from Trustee Kahl.**

### 5. INFORMATION/DISCUSSION ITEMS - GENERAL

A. Instructional Services – Presentation: Formative Data and Student Software in CVUSD Dr. Jayna Suter presented information on Student Software and Formative Data, including formative assessment and data collection, software to support formative practices, including usage information, grade spans and types of data; examples of diagnostic assessments, and overall software costs for the 2023-2024 school year. Dr. Suter responded to questions from Board members regarding cost prioritization for programs that are temporarily funded, feedback metrics for students using the programs, data inclusion in site School Plans for Student Achievement (SPSA), effects of student data assessments on student growth in meeting standards, the effects of gamification and leaderboards on student competitiveness, positive impact on teachers using the software, grade spans for benchmark assessments through Mastery Connect, learning strategies versus assessment, program compatibility with Universal Design for Learning (UDL), and program support for teachers and staff.

### B. Board of Education - CSBA Delegate Assembly Nominations

Dr. McLaughlin provided information on the CSBA Delegate Assembly nomination process. President Gill responded to a Board member's question regarding the role of the CSBA Delegate Assembly and how an interested trustee would become involved.

# C. Business Services – Approval of Amendments to Board Policy and Administrative Regulation 1330 – Use of School Facilities

Dr. Hayek provided background on the language amendments specified by Gamut related to charges for facility use by religious groups and as polling places. Dr. Hayek responded to a Board member's question regarding the impact on schools used as polling places and security measures put in place to prevent voters from entering the campuses.

**D. Business Services – Approval of Amendments to Administrative Regulation 3311 – Bids**Dr. Hayek provided background on the language amendments specified by Gamut related to changes on alternative bidding processes. Dr. Hayek responded to a Board member's question regarding the lease-leaseback process.

# E. Business Services – Approval of Amendments to Administrative Regulation 3311.3 – Design-Build Contracts

Dr. Hayek stated that the Gamut language amendments were similar to those amendments discussed during the previous agenda item.

# F. Business Services – Approval of Amendments to Board Policy and Administrative Regulation 3551 – Food Service Operations/Cafeteria Fund

Dr. Hayek provided background on the language amendments specified by Gamut related to guidance changes to regulations on cash reserves, the prioritization of purchasing product from US vendors unless the products are deemed inferior, and other language regarding food service operations. Dr. Hayek responded to questions from Board members regarding the requirement to cut the maximum amount of edible, donatable food and the inclusion of students in food waste reduction measures.

**G. Business Services – Approval of Amendments to Board Policy 3312 – Contracts**Dr. Hayek provided background on the legal verbiage updates specified by Gamut related to conflicts of interest for campaign contributions.

# H. Business Services – Approval of Resolution #24/24-16: Authorizing the Issuance of CVUSD Election of 2014 General Obligation Bonds, Series E, and Actions Related Thereto (Final Bond Issuance for Measure I)

Dr. Hayek provided information on the issuance process for the final issuance of bonds for Measure I and responded to questions from Board members regarding interest in issuing tax exempt bonds and risk factors connected to earthquakes and fires.
