Mr. Edward Weisz is an immigration attorney located in Woodland Hills. He has experience helping families navigate the immigration process for over 30 years in both New York and California. During his presentation, Mr. Weisz focused on the following points:

- Different types of citizenship
- The immigration process in the United States
- Individuals' rights when it comes to applying for citizenship
- Resources available for students of immigrants enrolled in US public schools
- The role of the court system during the citizenship process
- Resources/services available at low cost for individuals and families looking to apply for citizenship

Q: Are there other resources than Collision and ESPERANZA since these have a two-year wait that you may know of? A: Any private attorney can. SOCAL Chapter of Lawyers is a good place to look . All immigration courts have interpreters and even for dialects.

Q: Student with refugee visa here by himself doesn't want to apply for loans since he doesn't want it to affect his legal status, can he apply for loans or not with the new Public Charge law? A: Yes, if he has been granted asylum he can find help within special programs with asylum. He does not fall under the new public charge law.

Public Charge- is not for parents with food stamps for the child or children that are USA citizens.

Emergency Medical for pregnancy is ok and does not affect.

Q: Cancer adult does that apply like for a child? A: Hardship only for children under 21 to use Deportation Removal/Cancelation.
