III. Information/Discussion Items

A. Migrant Education Program by Maria D. Ponce-Montañez, Program Specialist

The Migrant Education program targets those families that have a parent or guardian that is or has been a migrant worker in agriculture, dairy or fishing industry for the past three years. This program offers free services such as:

- 1. School Meals
- 2. Medical Services
- 3. High School Credit Recovery Courses
- 4. Saturday School
- 5. Summer School
- 6. Transportation
- 7. Speech and Debate Tournament
- Q: Once a student qualifies, how long do they stay in the program? A: Three years
- Q: If you do find families that are eligible in Conejo Valley how long before they can receive services. A: It would be a year since that is how long it would take for the funds to be available.
- B. Presentation: Special Education Continuum

Erika Johnson provided more information in regards to Special Education. Some of the items of her presentation included:

Eligibility

13 categories that school districts test for and consider. No medical diagnosis required to suspect a learning disability

• An Individual Education Plan (IEP)

This defines what we will work on. This is a legal document that we agree to do something.

IEP defines: goals, services, and supports

This is a unique plan for each student.

Services

Related services

- 1. Speech therapy
- 2. Occupational Therapy
- 3. Counseling
- 4. Intensive Behavior Intervention
- 5. Nursing
- 6. Adaptive Physical Education
- 7. Physical therapy
- 8. Alternative/Augmentative Communication
- 9. Visually impaired Services
- 10. Deaf/Hard of hearing services

Special Academic Instruction (SAI) is provided by a special education teacher.

The following questions and answers (Q&A) from committee members are as follows:

- Q: Do parents know the student will be tested? A: Yes! We cannot test without your permission.
- Q: Who makes the recommendation teacher or parent? A: Both can do this.
- **C.** Presentation: Gifted and Talented Education (GATE) by Shauna Ashmore, Director of Student Support Services

Mrs. Ashmore explained that GATE is not a "pull out" program but rather something done in class. This does not mean that a student gets more work if he or she is done early, rather a student receiving differentiated assignments. They may work in small groups with other GATE students and high achieving students within class.

Process of identifying students:

- 1. All 3rd grade students are screened.
- 2. 4th 12th grade can be referred
- 3. Three assessments used and one is a non-verbal test.

GATE students can join clubs or teams on campus with other GATE students.

Enter academic competitions with other GATE students

GATE students become immediately eligible for GATE activities at their site or district-sponsored activities.
