Students

Intradistrict Open Enrollment

The Governing Board desires to provide enrollment options that meet the diverse needs and interests of district students. The Board believes in the concept of neighborhood schools and recognizes that student safety, parent involvement, and neighborhood/school peer relationships are three (3) important reasons for students to attend the school closest to their residence.

The Board also believes in the pedagogic value of socio-economically diverse learning environment. Attendance boundaries may be established and adjusted for the successful socialization of students which includes the ability to interact with others from a broad background of experiences and socio-economic levels.

The Superintendent or designee shall establish procedures for the selection and transfer of students among district schools in accordance with law, Board policy and administrative regulation.

It is the intent of the Board that every student living within the Conejo Valley Unified School District shall attend the neighborhood school serving the attendance zone in which the student's residence is located. The Board recognizes, however, that there are occasionally extenuating circumstances of the District which may necessitate out-of-zone attendance.

The parents/guardians of any student who resides within district boundaries may apply to enroll their child in any district school, regardless of the location of residence within the district. (Education Code 35160.5)

The Board shall annually review this policy. (Education Code 35160.5, 48980)

Enrollment Priorities

1. Any student enrolled in a district school that has been identified on the state's Open Enrollment Act list (Education Code 48354)
2. Any student enrolled in a district school designated by the California Department of Education as "persistently dangerous" (20 USC 7912; 5 CCR 11992)

3. Any student who is a victim of a violent crime while on school grounds (20 USC 7912)

4. Upon a finding that special circumstances exist that might be harmful or dangerous to the student in the current attendance area. Special circumstances include, but are not limited to, threats of bodily harm or threats to the emotional stability of the student. To grant priority under these circumstances, the Superintendent or designee must have received either: (Education Code 35160.5)

a. A written statement from a representative of an appropriate state or local agency, including, but not necessarily limited to, a law enforcement official, social worker, or a properly licensed or registered professional such as a psychiatrist, psychologist, or marriage and family therapist

b. A court order, including a temporary restraining order and injunction

Application and Selection Process

The Superintendent or designee shall calculate each school's capacity in a non-arbitrary manner using student enrollment, available space and appropriate staffing. (Education Code 35160.5)

For all other applications for enrollment outside a school's attendance area, the Superintendent or designee shall use a random, unbiased selection process to determine who shall be admitted whenever a school receives admission requests that are in excess of the school's capacity. (Education Code 35160.5)

Enrollment decisions shall not be based on a student's academic or athletic performance, except that existing entrance criteria for specialized schools or programs may be used provided that the criteria are uniformly applied to all applicants. Academic performance may be used to determine eligibility for, or placement in, programs for gifted and talented students. (Education Code 35160.5)

No student currently residing within a school's attendance area shall be displaced by another student transferring from outside the attendance area. (Education Code 35160.5) (cf. 5116 - School Attendance Boundaries)

Transportation

The district shall not be obligated to provide transportation for students who attend school outside their attendance area. However, upon request, the Superintendent or designee may authorize transportation contingent upon available space and funds. Priority for any such transportation shall be based on demonstrated financial need.

Open Enrollment List (Low-achieving schools)

A parent/guardian whose child is attending a district school on the Open Enrollment List as identified by the Superintendent of Public Instruction, and who wishes to have his/her child attend another school within the district shall apply for enrollment using the school choice application process and timelines. Students may transfer to another school within the district, as long as the school to which he/she is transferring has a higher Academic Performance Index (API). (Education Code 48354, 48356).

Parents/guardians are responsible for transporting their children to school.
