PREVAILING WAGES: The Department of Industrial Relations, State of California, has determined the general prevailing rates of per diem wages applicable to this work. The Contractor shall abide by the provisions of the California Labor Code § 1770-1781, et seq. In accordance with the provisions of the California Labor Code § 1773, the general prevailing rates of per diem wages and holiday and overtime work in the locality in which the work is to be performed has been obtained from the Director of the Department of Industrial Relations. The Contractor shall post a copy of the prevailing rate of per diem wages at the job site.
