Please Note

1. The AM PICKUP time is the time the bus leaves the stop.
2. Students need to be at their stop several minutes before the AM PICKUP time.
3. The PM DROP OFF time is the time the bus arrives back at the stop.
4. PM DROP OFF times may vary up to 15 minutes due to traffic conditions.
5. STUDENTS MUST BE OUTSIDE ANY WAITING VEHICLE FOR PICKUP
6. All Kindergarteners must be accompanied by a parent at the bus stop in the AM and met at the bus by a parent in the PM. Receiving parent or adult MUST be named on the school's EMERGENCY CARD
7. Parents and students must wait for bus driver to cross them if bus has already arrived at the bus stop.
8. All students MUST WEAR FACE MASKS while at the bus stop and while riding the bus.
9. Hand sanitizers will not be available due to state regulations (flammable substance)
10. Social distancing must be observed at the bus stops and on the bus.
11. A parent/guardian must remain at the bus stop until the bus arrives and their student's temperature has been taken and they have boarded the bus.
